**VOLUNTARY RELEASE – ASSUMPTION OF RISK AND INDEMNITY AGREEMENT**

The undersigned person requests and is granted permission (1) to enter RESTRICTED AREA, (2) to participate as driver, crew or assistant in racing events, (3) to complete for money, prizes, recognition or rewards, (4) to be covered by participants' hospitalization insurance as limited by the master insurance policy (all collectively herein called "permissive entry"). In consideration of 'permissive entry' to the restricted area, which is the area to which admission to the general public is prohibited which includes but is not limited to

the pit area, racing surface, infield, adjacent walkways, concessions, and other appurtenances (the undersigned) for myself, my personal representatives, heirs, next of kin, spouse and assigns, DO HEREBY:

1. RELEASE, DISCHARGE and CONVENANT NOT TO SUE the track operators, track officers, agents and employees (all herein collectively referred to as 'releases') from any and all claims and liability arising out of strict liability or ordinary negligence (active or passive) of any type of releases or any participant which causes the undersigned injury, death, damages, or property damage.
2. AGREE and HEREBY DO CONVENANT to hold release harmless and indemnity release from any claim, judgment, cost of defense or other expenses incurred by releases for any claimed active or passive negligence on the part of the releases arising out of my activities or presence in the restricted area or as a direct result of my activities or presence in the restricted area.
3. UNDERSTAND that my entry into the restricted area and/or participation in racing events contains DANGER and RISK OF INJURY or DEATH, those conditions of race surfaces from time to time and may become more hazardous, and that there is an INHERENT DANGER in racing which I appreciate and voluntarily assume, because I choose to do so. I have observed many races of the type that I seek to participate in. I have inspected the racing surface, access roads shoulder, equipment, barrier or lack thereof, lighting or lack thereof, and the weather conditions, I further know that other contestants and participants post a danger to me, nevertheless I VOLUNTARILY ELECT TO ACCEPT ALL RISK connected with my entry into the restricted area and/or participation in any event.
4. ACKNOWLEDGE that I am aware of all track and equipment safety regulations and I have complied with each regulation. If I have failed to do so, I ASSUME ALL RISK for myself and assume all liability to others for such failure and I hereby RELEASE "releases" for any failure in inspection my vehicle or others. I am not an agent; servant or employees of released and no oral representation have been made to me to sign this agreement.
5. AGREE that this agreement shall apply to any incident, injury accident or death occurring at the captioned track on the above date and for A PERIOD OF ONE (1) YEAR AFTER THE EXECUTION OF THE AGREEMENT. If any portion of the agreement is held invalid it is agreed that the balance thereof should continue in full force and effect.

### **MINOR RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT**

IN CONSIDERATION of being allowed to participate in any way in motor sports events or activities, and/or being permitted to enter for any purpose a restricted area, the parent(s) and/or legal guardian(s) of the minor(s) participant names below agree:

1. The parent(s) and/or Legal Guardian(s) will instruct the minor participant that prior to participation in any motor sport event or activity he/she should inspect the facilities and equipment to be used and if he or she believes anything is unsafe, the participant advise the officials of such condition and refuse to participate. The parent(s) and/or legal guardian(s) will perform the same described above and immediately advise officials of any conditions that they believe to be unsafe.
2. I/WE fully understand and acknowledge that:
  - a. There are risks and dangers associated participation in motor sport events and activities, which could result in bodily injury, partial and/or total disability, paralysis, and death.
  - b. The social and economic losses and/or damage, which could result from those risks and dangers described above, could be severe.
  - c. Those risks and dangers may be caused by the action, inaction or negligence of the participant or the action, inaction or negligence of others, including but not limited to, the "RELEASES" named below.
  - d. There may be other risks not known to us or are not reasonably foreseeable at this time.
3. I/WE accept and assume such risks and responsibilities for the losses and/or damage following such injury, disability, paralysis, death, however cause or whether caused in whole part by the negligence of the "RELEASES" named below.
4. I/WE HEREBY RELEASE, WAIVE DISCHARGE, and CONVENANT NOT TO SUE the promoter, participant, racing organization sanctioning organization or any subdivision thereof, track operator, track owner, officials, snowmobile owners, driver, pit crews, any person in the restricted area, promoters, sponsors, advertisers, owner, their officers, agents and employees, organization officials, all for the purpose herein referred to as "RELEASED" from all liability to the next of kin or any and all claims, demands, losses or damages of account of any injury, including but not limited to the death of the participant or damage to property, caused or alleged to be caused in whole or in part by the negligence of the "RELEASED" or otherwise.
5. On behalf of the participant and individually parent(s) and/or legal guardian(s) for the minor participant executes this waiver and release. If despite this release, the participant makes a claim against any "Releases". The parent(s) or legal guardian(s) will reimburse the "Releases" and their insurance company for any money which they have paid to the participant, on his behalf and hold them harmless.

**I/WE HAVE READ THE ABOVE WAIVER AND RELEASE, UNDERSTAND THAT I/WE GIVE UP THE SUBSTANTIAL RIGHTS BY SIGNING AND SIGNING IT VOLUNTARILY WITHOUT INDUCEMENT.**
